This trial will be held in an outdoor livestock arena (adequate signage will be provided) with matted flooring over packed dirt. One ring and one blind (10' x 20') will be located on the back left side of the arena. A benching area will be located near the ring. Daily parking is available in multiple lots around the arena (no shade); please observe all No Parking signs. RV parking will be handled through The Escambia County Equestrian Center at \$20.07/night for full hook-ups. Arena restrooms are available. Benching with electricity in the main stable area is available

through the Equestrian Center's reserved grooming stalls for \$18.28/day (discounts available for multiple days). Stalls are lockable for overnight security if you bring your own chain/lock.

# Classes offered: Instinct, Novice, Open, Senior, Master, Crazy8s Pre-Entry opens February 5th, 2021

**Pre-Entry closes** February 22, 2021 (post-marked) or when the 8-hour judging limit is reached.

**LATE ENTRIES: electronic only -** available through March 1<sup>st</sup> - **only if** 8-hour judging limit is not reached during Pre-Entry period (Pro-Tip: do NOT risk it).

All breeds and mixed breeds welcome! Registration with BHA is required and can be done online at www.barnhunt.com. BHA registration fee is \$30 and is a lifetime fee for that dog. There are no annual fees with BHA, and no membership fees for dog owners.

Check-in 7:30 am, No Briefings per BHA COVID-19 Rules, First dog in ring 8:30 am

Trials will run concurrently (I, N1, N2, O1, O2, C8s, S1, S2, M1, M2). Trial to Trial Move-ups will be allowed if the Trial Secretary (Lauren Smitherman) is informed at least 30min before the start of the next class.

Please read the current COVID-19 Rules (<a href="www.BarnHunt.com/rules/covidrules.pdf">www.BarnHunt.com/rules/covidrules.pdf</a>) and be sure that you bring your signed COVID-19 Waiver (located at the end of the premium) and masks. Points of Emphasis – Wear a mask. Properly (covering mouth AND nose). At ALL times. Without complaining or being prompted. No masks with plastic vent valves. Face shields are allowed in addition to (but not in place of) masks. Wash/sanitize hands OFTEN but particularly before entering the Blind. SOCIAL DISTANCE (10') as often as humanly possible. Stay Safe!

## **General Information and Policies**

It is the responsibility of each competitor to read and understand the current Barn Hunt Association, LLC Rules prior to participating in this event:

Possessing or training with personal tubes and/or live rats is NOT permitted on the event grounds at any time.

Dogs must be leashed or crated when not in the blind or ring. Please pick up after your dog and dispose of waste in appropriate containers. Multiple potty areas are available.

**Barn Hunt Grounds:** Barn Hunt rules apply to any activities held at The Escambia County Equestrian Center and surrounding property.

Leashes and Collars: Bark/Electronic Collars/Devices, and head collars are NOT allowed on BHA event grounds. Approved collars include: flat snap or buckle collars and leather or nylon leads, limited slip martingale and single piece slip collars/leads and all harnesses. Dogs MUST run "naked," without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can be <a href="mailto:easily">easily</a> and <a href="mailto:quickly">quickly</a> removed and replaced (see BHA Competitor Rulebook page 10 for more specifics).

**Dog Aggression:** Any dog behaving in a threatening or aggressive manner toward another dog or person may be dismissed from the event if justification is found by the judge and/or Event Committee. Entry fees will not be refunded.

**Bitches in Season:** Are eligible for entry but will be required to be kept separate from all other dogs and will run at the end of their class. They must always wear panties (including on course) while not being pottied. They must be pottied in a designated area away from the other dogs. Entry fees for bitches that come into season will be refunded until the closing date of February 22, 2021, if you wish to withdraw.

The trial secretary must be notified prior to or upon arrival. Failure to do so will result in a disqualification and dismissal from the event.

Videotaping and Photography: Is allowed and encouraged!

**Volunteers:** Are appreciated and needed! **Sportsmanship:** All competitors/handlers and spectators are expected to follow the rules of the BHA and demonstrate good sportsmanship. Please do not discuss hide placements or any details of a dog's performance that may provide information or clues to other handlers or may be overheard. Please be cognizant of teams competing in the ring and avoid loud or disruptive distractions.

**Crating:** Dogs must be leashed or crated when not actively working and never tied out/left attached to anything other than a human.

**Awards:** Qualifying ribbons will be awarded for all qualifying runs in all classes. Placement awards for 1<sup>st</sup> through 4<sup>th</sup> will be awarded for Novice, Open, Senior, and Master in each height division for the A classes and all heights combined for the B Classes. New Title rosettes will be awarded for all class levels. High in Class ribbons will be awarded to the fastest qualifying run in each class, excluding Instinct.

**Food services:** A concession stand will be open in the arena. Several restaurants are within 15 minutes of the venue.

**Payment and entry information:** Entries will NOT be accepted without signatures (electronic is acceptable) and payment, entries are invalid without a signed Release Agreement Form.

Owners are responsible for entry errors. Please write clearly and proofread your entry. BHA will not make corrections once results are submitted. Incomplete forms, non-payment, and returned checks are invalid entries. There is a \$30 fee for all returned checks. Entries accepted on a first come/first served basis.

No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of any god(s), public emergency, act of a public enemy, or any other cause beyond the control of

the Event Committee. Entry fees will not be refunded if a dog is absent, disqualified, sick, excused, or barred from competition by action of the Event Committee.

Refunds requested AFTER the Closing Date will be accommodated at the discretion of the Trial Secretary.

Conflicts: We would like to accommodate each and every conflict but that will more than likely be impossible, and you may have to make a choice between events. The running order for classes will be posted at each ring every morning. If you have a conflict, please ask the blind steward to put a "C" by your name. No exhibitors are allowed to alter the running order – Blind Stewards or Scribes ONLY. If you are not within earshot of the staging area when your blind is called, we will fill your space with someone that is present. When you are available to run, please check in and we will assign you to a new blind. We cannot guarantee you will run immediately upon checking in. We cannot hold any class for any reason.

## **BHA COVID-19 WAIVER**
